General Terms

These terms apply to the entire website and any email or other type of communication between you and Onyx.

Under no circumstances shall Onyx team be liable for any direct, indirect, special, incidental or consequential damages, including, but not limited to, loss of data or profit, arising out of the use, or the inability to use, the materials on this site, even if Onyx team or an authorized representative has been advised of the possibility of such damages. License
